### Quarterly Activities Report and Appendix 4C – June 2023 Quarter

#### **SUMMARY**

- Positive quarterly cash flows of \$7.2m generated from underlying operating activities for the June 2023 quarter (Q4 FY23) compared to (\$1.6m) of negative cash flows from underlying operating activities for the previous quarter (Q3 FY23). The lower operating cash flows in Q3 FY23 were due to an additional fortnight of wages during Q3 FY23, amounting to \$6.2m of incremental cash outflows.
- \$16.0m of unused debt facilities available as at 30 June 2023. Cash on hand as at 30 June 2023 was \$3.3m, resulting in total available funding of \$19.3m.

### **Quarterly Activities**

There were no material changes in the principal activities within the Company's Cleaning and Security segments during the quarter ended 30 June 2023.

The Group's total revenue of \$68.0 million for the 3 months ending 30 June 2023 was in line with total revenue of \$68.2m in the March 2023 quarter.

Contract revenue of \$62.7m in Q4 FY23 increased by \$0.3m or 0.5% compared to contract revenue of \$62.4m in Q3 FY23; which partially offset the \$0.5m decline in ad hoc revenue during the same period.

Pleasingly, the Group's total revenue of \$136.2m for the second half of the FY23 financial year (H2 FY23) increased by 5.1% compared to total revenue of \$129.6m in the previous half (H1 FY23) due to the Company winning new long-term contracts and the Company continuing to pursue customer industry diversification.

Gross profit margin percentage of 14.4% for H2 FY23 improved by 0.4 percentage points compared to gross profit margin of 14.0% in H1 FY23, leading to a full year FY23 gross profit margin of 14.2%.

The Company's gross profit margin improved in the face of macro-economic challenges such as high inflation, low unemployment resulting in a tight labour market, wage increases and pressure on supply chains.
