### Quarterly Activities Report and Appendix 4C – September 2023 Quarter

#### **SUMMARY**

- A negative cash flow of \$3.5m from underlying operating activities was recorded for the Q1 FY2024 quarter. The major items that impacted the Q1 FY24 and FY23 operating cash flows were:
  - an additional fortnight of wages during the quarter, over and above the previous June quarter, amounting to incremental \$6.5m of cash payments in Q1 FY2024; and
  - favorable timing of debtor collections in late June 2023 and 2022 that contributed to the strong June quarter cash collections (but reduced the amount available for collection in the September quarters).
- Given the extra fortnight of wages in it, the September quarter is historically a period in which there are significant net cash outflows. The result for Q1 FY2024 compares favourably to previous corresponding period of Q1 FY2023 (negative cash flow of \$4.7m).
- \$11.2m of unused debt facilities available as at 30 September 2023. Cash on hand as at 30 September 2023 was \$1.8m, resulting in total available funding of \$13.0m.

### **Quarterly Activities**

There were no material changes in the principal activities within the Company's Cleaning and Security segments during the quarter ended 30 September 2023.

Pleasingly, the Group's total revenue of \$71.3 million for the 3 months ending 30 September 2023 increased by \$3.3m or 4.9% compared to total revenue of \$68.0m in the June 2023 quarter, due to the Company winning new long-term contracts and continuing to pursue customer industry diversification.

Contract revenue of \$66.5m in Q1 FY24 increased by \$3.8m or 6.1% compared to contract revenue of \$62.7m in Q4 FY23; which more than offset the \$0.5m decline in ad hoc revenue during the same period.
