# Quarterly Activities Report and Appendix 4C – December 2023 Quarter

# SUMMARY

- Positive quarterly cash flows of \$3.2m generated from underlying operating activities for the December 2023 quarter (Q2 FY24) compared to negative cash flows of \$3.5m from underlying operating activities for the previous quarter (Q1 FY24).<sup>1</sup>
- \$11.7m of unused debt facilities available as at 31 December 2023. Cash on hand as at 31 December 2023 was \$2.1m, resulting in total available funding of \$13.8m.

# Quarterly Activities

On 22 December 2023, the Company announced it had entered into a binding scheme implementation agreement with MS Journey Pty Ltd, a subsidiary of SoftBank Robotics Singapore Pte Ltd to acquire 100% of the issued capital of Millennium Services Group Limited by way of a scheme of arrangement (**Scheme**). The announcement also included an indicative timetable relating to the issuing of the Scheme Booklet, Scheme record and implementation dates.

There were no material changes in the principal activities within the Company's Cleaning and Security segments during the quarter ended 31 December 2023.

The Group's total revenue of \$77.9 million for the 3 months ending 31 December 2023 increased by \$6.6m or 9.3% compared to total revenue of \$71.3m in the September 2023 quarter. Pleasingly, total revenue for the first half of FY24 increased by \$19.6m or 15.1% compared to total revenue of \$129.6m in the previous corresponding period.

Contract revenue of \$69.5m in Q2 FY24 increased by \$3.0m or 4.5% compared to contract revenue of \$66.5m in Q1 FY24 due to the Company winning new long-term contracts and continuing to pursue customer industry diversification.

Adhoc revenue of \$8.4m in Q2 FY24 increased by \$3.6m or 75.0% compared to adhoc revenue of \$4.8m in the previous quarter due to the increase in additional services provided to clients over the extended retail trading hours in December 2023 and the Company winning new security project work.

The single most material item that impacted the Q1 FY2024 operating cash flows was an additional fortnight of wages during the quarter, over and above the previous June 2023 quarter, amounting to an incremental \$6.5m cost in Q1 FY2024.

# Appendix 4C Cashflows

There were no material changes to the debtor or creditor payment terms during the quarter. The table below lists the material items that impacted the reported cash flows from operating activities for Q2 FY24 and the half year period to December 2023.

There was material investment in working capital during the first half of FY24 to expand the Company's customer base. As noted previously, total revenue for the first half of FY24 increased by 15.1% compared to the previous corresponding period.
