Results of Scheme Meeting

Millennium Services Group Limited (**Millennium**) (ASX:MIL) announces that Millennium Shareholders today voted in favour of the proposed scheme of arrangement (**Scheme**) pursuant to which 100% of the issued capital of Millennium will be acquired by MS Journey Pty Ltd (**SoftBank Robotics BidCo**).

Unless otherwise indicated, capitalised terms used in this announcement have the meaning given to them in the Scheme Booklet.

Results of the Scheme Meeting

In accordance with ASX Listing Rule 3.13.2 and section 251AA of the *Corporations Act 2001* (Cth), Millennium advises that the resolution to approve the Scheme (**Scheme Resolution**), as set out in the Notice of Scheme Meeting included in the Scheme Booklet dated 12 March 2024, was approved by the requisite majorities of Millennium Shareholders at the Scheme Meeting held earlier today.

In summary:

- 97.27% of Millennium Shareholders present and voting (in person or by proxy, attorney or corporate representative) voted in favour of the Scheme Resolution; and
- 99.97% of the votes cast by Millennium Shareholders (either in person or by proxy, attorney or corporate representative) were in favour of the Scheme Resolution.

Details of the valid proxies received and votes cast at the Scheme Meeting are set out in an attachment to this announcement.

Second Court Hearing

The Supreme Court of New South Wales will hear an application by Millennium for approval of the Scheme at the hearing scheduled for 3.00pm (Sydney time) on Monday, 22 April 2024 in the Supreme Court of New South Wales at Law Courts Building, 184 Phillip Street, Queens Square, Sydney NSW 2000.
